WWTA continues our partnership with the Washington State Parks Department to help maintain shoreline campsites on the Cascadia Marine Trail. Volunteers can join our work parties this spring:

- Blake Island State Park on April 21 (the day before Earth Day!) and at

- Blind Island State Park on May 12.



We will be clearing trails, footpaths and tent beds, removing invasive plants, and generally cleaning up



the sites. You can paddle over or catch a boat ride with the Park Ranger.

Public Access:

- Participating as member of Washington State Park's Boating Advisory Council.
- Participating as member of Washington State Parks Paddling Advisory Committee.
- Participating in Washington Boating Alliance (NW Marine Trade Association Hosted).
- Working with Washington State Parks, Department of Natural Resources, and the County Agencies of Mason, King, Whatcom, San Juan Islands, Snohomish, and Spokane on development of future public water access sites.

Trails:

Visited 50 Cascadia Marine Trail camp the organization records updated sites to review their condition and meet with the local site manager about any issues/concerns. Replaced CMT signs at these sites with new laminated CMT and

site specific signs.

- Participated in planning and development meetings of the Skykomish-Snohomish Rivers Recreation Coalition's Sky To Sound Water Trail.
- Participated in the "Big Paddle" Inauguration of the Lewis River to Vancouver Lake Water Trail.

- Visited 5 potential new CMT sites to meet with local land managers on planning "Next Steps".

- Activities planned for 2018 are a combination of "Trail Maintenance" and "Trail Development/ Expansion" along with some "get acquainted"

- Paddling events such as "Work Parties" and "New Trail Inaugurations".

- Central to the summer activity plans are the annual "Visit All Cascadia Marine Trail Sites" paddles and planned Work Parties on Blake, Blind, Shaw, and Pt. Doughty (and perhaps more depending on requests).

- Other Water Trail paddles on the table are Willapa Bay Trail, Lewis River Trail, Skykomish/Snoqualamie Sky to Sound Trail, Lower Spokane River Trail, Tapteal River Trail, and part of the Greater Columbia River Trail along the Hanford Works.
